Avery: Seen Patrick in action. He came in and hit the ground running. Trusted by staff. Clemons: Patrick is doing fantastic at Parks. How does this compensation rate compare?

Krapohl: Hard to compare because of the range of scopes.

Clemons: Operating at a tight budget, will this affect that?

June: No, he costs less as part of the new plan.

Figueroa: Less overhead.

Clemons: Non-union position - are there built in steps? Can we set steps?

Lane: Suggest doing a study and work on a policy for upgrades.
